Bidders' guide to electronic bid
security at DCC

August 2016

When DCC requires that Bid Security be provided for a project, the requirement will appear on the MERX abstract as per the image below.

Bonding Requirements

Buyer Requires E-Bonding or Electronic Fund Transfer

Two methods are accepted at DCC for Bid Security:

- Digital bid bond
- Wire transfer

Refer to Section 5 of the Instructions to Tenderers for Electronic Bidding for requirements.

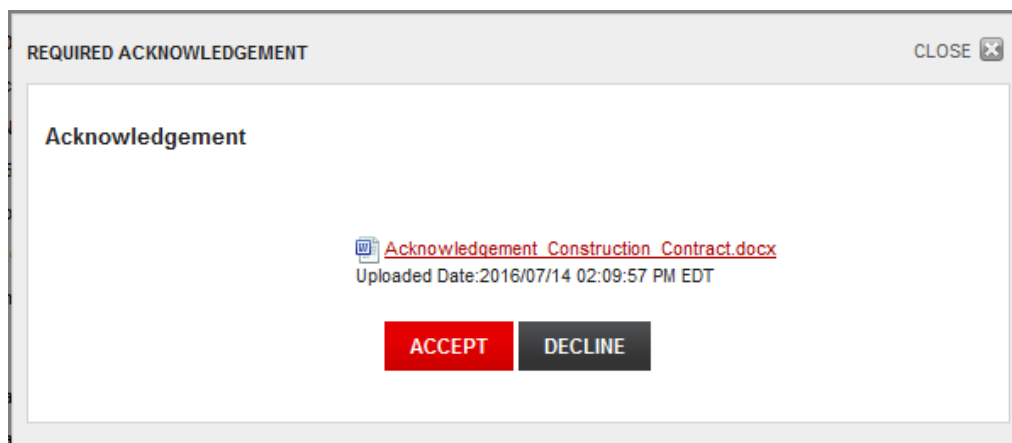

Once you click on Place Bid, the following window may pop up. This window may also pop up when you want to read the full MERX abstract. If that was the case, then it will not appear at this stage.




Click on the document link and read the information enclosed. Once done, click on the ACCEPT button to continue. If you click DECLINE, you will not be allowed to bid.

After this step, you will be returned to the preceding screen and will have to click on the SUBMIT BID button again

Electronic Fund Transfer (EFT)

On the second screen is where you have the option to select e-bonding or EFT.

If you select E-bonding, you must upload your digital bond here.

Electronic Funds Transfer / Wire Transfer

IMPORTANT:

- The funds must have been deposited in DCC's account by the date and time of closing
- Ensure the EFT reference number is included with your transfer
- While wire transfers are fairly quick, DCC has no control over the banking system. Give yourself sufficient time to ensure that your transfer arrives in DCC's bank account before the date and time of closing
